Use of Internet, St Luke's Learning Platform & Microsoft Teams

The internet is increasingly becoming one of the most effective ways of developing and extending the pupils' learning. At St. Luke's the children are very lucky to have access to laptops and therefore the internet on a daily basis. Wolverhampton Local Authority operate a filtering system that restricts access to inappropriate materials and sites. Children are taught eSafety which includes using the internet responsibly through Google safesearch, carefully vetted websites and closed access to our own Learning Platform (which requires a username and password to gain access). Children will also have access to a school email account and Microsoft teams where they can store work, access it at home for homework and share in discussion forums. School staff and the Local Authority's eServices team regularly monitor use of these resources.
